General Terms and Conditions (GTC)

Karlsruhe Model United Nations (KAMUN)

1. Ambit

- 1.1. These terms and conditions apply to the UN simulation conference "KAMUN 2023 The Black Forest Summit" organized by the Model United Nations initiative Karlsruhe e.V., hereinafter referred to as MUNIKA.
- 1.2. The conference takes place from Friday, the 17th of November 2023 to Sunday, the 19th of November 2023.

2. Registration and Conclusion of Contract

- 2.1. Registration takes place online only via https://mymun.com/conferences/kamun-2023 with the provided online form.
- 2.2. The registration is deemed accepted as soon as the online registration is completed including the payment of the participation fee has been made and has been credited to the recipient's account. MUNIKA e.V. has the right to reject applications up to four weeks after registration.
- 2.3. Participants must be at least 18 years of age. Exceptions require the consent of the legal guardian and the KAMUN secretariat.

3. Contents of the Conference

- 3.1. Upon conclusion of the contract MUNIKA e.V. provides the services concerning the organization of the UN Simulation Conference KAMUN The Black Forest Summit 2023. MUNIKA e.V. makes no warranties, but provides only services, so that no liability can be taken for a success of the organization and the event. The registration fee includes
 - a) the organization of the conference by MUNIKA e.V. and organizational support to the participants during the conference,
 - b) the participation in all events offered by MUNIKA e.V. during the conference,
 - c) the organization and partial provision of catering during the conference.
- 3.2. MUNIKA e.V. is entitled to change individual conference content for functional reasons,

without the consent of the participant.

4. Revocation for Distance Contracts

4.1. The participant as consumer may revoke his contractual declaration within two weeks without indicating any reasons in text form. The time period begins no earlier than upon receiving this notification. Timely dispatch of revocation shall suffice to meet the revocation deadline. The revocation is to be sent to the below mentioned address or email.

5. Cancellation

- 5.1. A cancellation must be made in text form. The time of receipt of the cancellation at the recipient is decisive for the timeliness of the resignation.
- 5.2. In case of cancellation up to 3 weeks prior to the conference the participant will be reimbursed 50 % of the registration fee.
- 5.3. In case of cancellation within 3 weeks prior to the conference the participant will be not be reimbursed.

6. Cancellation of the Conference

6.1. MUNIKA e.V. reserves the cancellation of the conference for reasons which it is not responsible for (e.g. power failures, global and local epidemics, natural disasters and armed conflicts). In case of cancellation a full refund of any fees already paid takes place. Further claims by the participant, in particular damage compensation claims of any kind, are excluded except in cases of intentional or grossly negligent behavior on the part MUNIKA or its agents.

7. Termination

7.1. The mutual right of extraordinary termination for cause during the multi-day conference remains unaffected. A notice shall be given in text form.

8. Payment Terms

- 8.1. For the conference and other services the price agreed-upon in the contract is binding.
- 8.2. The payment of the conference fee is necessary for completing the registration
- 8.3. MUNIKA is entitled to ask the participant to provide evidence of payment made (e.g. credit slip). In case such a proof cannot be made MUNIKA e.V. has the right to exclude

the concerned person from participating in the conference.

9. Usage of Personal Data of Participants

- 9.1. The data conveyed by the participant is used according to the legal provisions of data protection of the MUNIKA e.V. and processed determined by its function. Specific applying legal provisions:
- 9.2. Personal data of the participants, especially the registration documents, are stored by the MUNIKA e.V. according to the requirements of the European General Data Protection Regulation (GDPR, viewable under https://gdpr-info.eu/) and deleted when legal storage time runs out.
- 9.3. The names of all participants are going to be published related to the documentation of the conference and their pre-formulated position papers which will be reused anonymized for training purposes. The participant agrees upon the publication and reuse of personal data for these purposes.
- 9.4. Furthermore the participant agrees to be portrayed on pictures and in cinematic documents made by other participants or members of the organizational board for documentation and report during the conference. The publication of these pictures and cinematic documents on online platforms and in print, especially in social media networks, is accepted. This includes use for advertisement of future conferences by MUNIKA e.V. and use of pictures by Sponsors. This agreement can be withdrawn at any time before the conference in writing.

10. Instructions and Disqualifying Criteria

- 10.1. Instructions of the members of the organization team of KAMUN The Black Forest Summit 2023 as well as the instructions of the staff members of the KIT must be complied with.
- 10.2. A refusal against the in paragraph 10.1 mentioned instructions can be punished with the exclusion from the conference. In case of the violation of social habits, making the carrying out of the conference more difficult and threatening the smooth process of the conference the participant will be excluded as well. The decision is to the discretion of the organizational team. Participants excluded due to their own fault do not have any right to claim for financial damages.
- 10.3. All conference rooms and buildings are strict non-smoking areas according to the house rules. Noncompliance will be punished with exclusion from the conference.

- 13.2. On the contractual relationship under the law of obligations German law finds application. The standard UN-sales law is not permitted.
- 13.3. In case single terms of this contract are invalid the validity of the other terms is untouched.
